Request For Proposal are invited for Preparation of Wildlife Conservation and Management Plan for Forest land at Gangrel - 2.08 Hec.

Please refer to the advertisement dated 10.11.2017 regarding the " Request For Proposal are invited for Preparation of Wildlife Conservation and Management Plan for Forest land at Gangrel - 2.08 Hec.".

Earlier, EOI was published for Preparation of Wildlife Conservation and Management Plan for Forest land at Gangrel. Now three place "Rajmergarh", "Amadob" and "Kodar" are added in the entire RFP.

The all amendments in RFP document are as follows -

- 1) "Request For Proposal are invited for Preparation of Wildlife Conservation and Management Plan for Forest land at Gangrel - 2.08 Hec."

Amendment: After adding three places, The above should read as below:-

"Request For Proposal are invited for Preparation of Wildlife Conservation and Management Plan for Forest land at Gangrel (2.08 Hec.), Amadob (3.253 Hec.) Rajmergarh (6.699 Hec.) and Kodar (14.395 Hec.)"

- 2) Bidder Agency has to submit separate proposal (Technical Bid, Financial Bid, Form Fees, EMD) for every place as per "Preparation of Proposal" and superscripted as -
 - a. "RFP for Preparation of Wildlife Conservation and Management Plan for Forest land at Gangrel (2.08 Hec.),"
 - b. "RFP for Preparation of Wildlife Conservation and Management Plan for Forest land at Amadob (3.253 Hec.)"
 - c. "RFP for Preparation of Wildlife Conservation and Management Plan for Forest land at Rajmergarh (6.699 Hec.)"
 - d. "RFP for Preparation of Wildlife Conservation and Management Plan for Forest land at Kodar (14.395 Hec.)"
- 3) Bidder Agency has to submit EMD of Rs. 10,000/- for every places (Gangrel, Amadob, Rajmergarh & Kodar) and purchase RFP form of Rs. 2,000/- for every places.
- 4) A. The RFP form can be purchased from Chhattisgarh Tourism Board by paying cash Rs. 2,000/- (per Form for each places) or can be downloaded from the web site (www.tourism.cg.gov.in) and RFP form fees (in the form of D.D./Banker cheque in favour of "Managing Director, Chhattisgarh Tourism Board, Raipur") will be payable on submission of the RFP (per Form for each places).
B. EMD of Rs. 10,000/- (Ten thousand) in the form of D.D./Banker Cheque in favour of "Managing Director, Chhattisgarh Tourism Board, Raipur" should be submitted for Each Place.
